- Valid proof of identity and age (either: driver's license, passport, military ID, certified birth certificate).
Form of ID used must be in English.
- If an applicant is unable to appear before the clerk, you must have an absent applicant form completed and notarized from the applicant along with an original form of identification for the applicant.
- Necessary fees (listed above).

If your situation is unique please speak to a clerk before completing the attached application to ensure you have all of the required information.
